Warranty

This puppy, to the best knowledge of the seller, is in good health at the time of sale, and has been inspected by a Veterinarian. Any known defects are noted at the end of this document. Until the buyer has had possession of the puppy for 72 hours, the seller will warranty for parvo and distemper. Until the puppy reaches one year of age, the seller will warranty for a death caused by a congenital disease. This constitutes the complete warranty between the seller and the buyer and no other representations or promises apply either stated or implied.

In order for compensation to be made, the buyer must provide the seller with a written veterinarian certification verifying the disease (and, if applicable, death) of the puppy. Compensation is limited to refund of the purchase price of the puppy only. With respect to the warranty for contagious diseases, the purchase price will be refunded only if the puppy is returned to the seller. The warranty for death due to a congenital disease shall be void if the puppy is euthanized without the consent of the seller.

In order to activate these warranties, the buyer must take the puppy to a veterinarian within 48 hours of purchase for a wellness exam. A copy of the receipt and/or statement of the results of the exam must be returned to the seller within 5 days of the wellness exam of the puppy.

The warranty does not cover adverse reaction to vaccines, medications, hypoglycemia, or any complications resulting from surgery, moreover, the seller is not responsible for any veterinarian fees incurred by the puppy.

The puppy is sold by the seller to the buyer for use as a pet, and the seller provides no warranty as to the suitability of the puppy for other purposes,

including but not limited to showing or breeding. Seller recommends that the puppy be spayed or neutered by the age of 6 months. If, for any reason, the buyer is unable to continue to keep and care for the puppy the buyer agrees to find a responsible and loving home for the puppy or contact the seller for rehoming assistance. The buyer agrees to never, under any circumstance, give the puppy to a rescue group, shelter, or humane society. Furthermore, the buyer agrees to never abandon, dump, or sell or donate puppy to a research facility.

The warranties apply only to the original buyer and do not apply in the event the buyer transfers the possession or ownership of the puppy to a third party.

This document, including the warranty, shall be interpreted and construed in accordance with the laws and statues of the state of Iowa. The venue for any litigation concerning this warranty shall be Iowa district court in and for Van Buren county Iowa under a non-jury proceeding.

All sales are final except as provided in the warranty described herein. I have read, understand and agree to the terms of this document, including the warranty provisions.

Terms of Sale

Puppies are shown and sold by appointment only. All interested parties must submit a purchase application prior to coming. No business will be transacted without submitting an application or having an appointment.

Puppies are kept and cared for here until they are considered ready by me. This is typically 10 to 12 weeks of age. Puppies NEVER leave before I feel they are completely, 100% ready to go to a new home. Transitioning to a new home is stressful for a pup, so its important that each pup goes when he/she is ready, not before on an arbitrary date. This is not a debatable or negotiable topic.

All of my puppies are sold as pets and are available to loving, permanent homes. It is understood that sometimes things happen that cannot be avoided. Should you find yourself unable to keep your puppy/dog and do not have someone that can responsibly care for the dog please contact me. One of my puppies is always welcomed back here. A returned dog/puppy for any reason other than those covered in the health warranty is not eligible for a refund.

Because puppies are sold as pets, registration papers are not provided. If you are looking for a pup for breeding purposes, please contact me. Breeding puppies are sold at different prices and with different criteria.

Payments accepted are cash, United States postal money orders or debit/credit card. All card transactions are processed via square.com and incur a 4% service charge.

Deposits are non-refundable for any buyer caused incident or situation. Deposits are only refundable if the pup cannot be provided by any cause of Providence Puppies.

Shipping is not available at this time.

A 50% non-refundable deposit is required to hold a puppy until it is ready to leave. All puppies are considered available until a deposit is received. Please be aware that simply inquiring about a puppy and saying you are very interested does not give you a claim to that pup.

Above all, I want to do my best to ensure that my puppies go to good homes, where they are cared for properly. It is my concern that my puppies do not end up in situations where they are in jeopardy of neglect or abuse.
